## After School Program

Dear Parents:

We welcome you and your child to the new school year at U-Prep! We will be offering the After School Program again this year and are aiming to meet all of your needs. This year the After School Program will start on Tuesday, August 16<sup>th</sup>. The After School Program is offered every day that school is in session Monday-Thursday from 3:15 – 5:30 and Fridays from 2:45 to 5:30 except on days with special schedules.

The After School Program teacher will provide students with opportunities for physical activity, will give each child a healthy snack, and maintain a period of quiet for students to do homework. The homework policy is that students will bring their homework and/or other work to the After School Program daily to take advantage of the time to complete tasks given to them by their teacher. At this time, we do not have tutors available to give academic help.

### ***After School Program Pricing:***

The After School Program is \$5.00 per day that your student attends regardless of the amount of time the student is present.

Payments can be made on a weekly or monthly basis, whichever works best for you. If you wish to pay on a weekly basis, payment will be due on the last day of the week for After School care for the following week. If you wish to pay monthly, payment is due on the first day of the new month. The per day fee is an effort to accommodate parents who may only need after school care periodically or certain days (i.e.: Tuesday and Thursday). You will be charged according to your child's daily log sheet.

*If you have an outstanding balance that exceeds \$50.00 your child may be dropped from the program until either payment is received or an arrangement is made with the School Business Manager.*

The After School Program uses room 129 located in the main building across from 299. The program will often utilize another facility (gym, quad, computer lab) when available. The location of the students will be clearly posted if not in 129. If your child has permission to walk home from the after school program, dismissal time for them is 5:30. With parent permission students may leave the program to walk home prior to 5:30.

If you are interested in having your child attend the After School Program, please fill out the After School Information packet attached and return it with payment to reserve your spot in the program. ***Your child may begin attending on August 16<sup>th</sup> and should report to room 129. Students that require assistance finding 129 may report to the main office for assistance.***
